**From Birmingham, AL:** US 231 South toward Troy, Alabama. Turn right onto AL-87 S continue for 7.7 miles. Turn slight left onto AL-167 S. Continue to follow AL-167 S (Cross into Florida) until it becomes SR-79 S in Florida. Stay on SR-79 S for approximately 6 miles and turn right onto Triple Lane. Field half mile on the right.

**From Mobile, AL:** I-10 East for approximately 150 miles to exit 112 SR-79 N. Turn left toward Bonifay follow for 10 miles turn left onto Triple Lane. Field half mile on the right.
